# TITLE: RESOLUTION COMMITTING TO DCA'S FOURTH ROUND AFFORDABLE HOUSING PRESENT NEED AND PROSPECTIVE NEED NUMBERS AS MODIFIED

**WHEREAS**, on March 20, 2024, Governor Murphy signed into law an Amendment to the Fair Housing Act (N.J.S.A. 52:27D-301 *et seq.*) (hereinafter "Amended FHA"); and

**WHEREAS**, the Amended FHA requires the Department of Community Affairs ("DCA") to produce non-binding estimates of fair share obligations on or before October 20, 2024; and

**WHEREAS**, the DCA issued a report on October 18, 2024 ("DCA Report") wherein it reported its estimate of the obligation for all municipalities based upon its interpretation of the standards in the Amended FHA; and

**WHEREAS**, the DCA Report calculates Northvale's Round 4 (2025-2035) obligations as follows: a Present Need or Rehabilitation Obligation of 8 units and a Prospective Need or New Construction Obligation of 112 units; and

**WHEREAS**, the Amended FHA provides that the DCA Report is non-binding, thereby inviting municipalities to demonstrate that the Amended FHA would support lower calculations of Round 4 affordable housing obligations; and



**WHEREAS,** pursuant to N.J.S.A. 52:27D-304.3, a municipality's average allocation factor is comprised of the equalized nonresidential factor, income capacity factor, and land capacity factor and shall be averaged to yield the municipality's average allocation factor; and

**WHEREAS**, the Amended FHA further provides that "[a]ll parties shall be entitled to rely upon regulations on municipal credits, adjustments, and compliance mechanisms adopted by COAH unless those regulations are contradicted by statute, including P.L. 2024, c.2, or binding court decisions" (N.J.S.A 52:27D-311(m)); and

**WHEREAS**, COAH regulations authorize vacant land adjustments as well as durational adjustments; and

**WHEREAS,** the DCA has released a Geographic Information Systems spatial data representation of the Land Capacity Analysis for P.L. 2024, c.2 containing the Vacant and Developable land information that serves as the basis for calculating the land capacity factor; and

**WHEREAS, Northvale** has reviewed the lands identified by the DCA for the land capacity factor with respect to the MOD-IV Property Tax List data, construction permit data, land use board approvals, configuration, and accessibility to ascertain whether these identified developable lands may accommodate development; and

WHEREAS, based on the foregoing, Northvale relies on the DCA calculations of Northvale's fair share obligations as modified herein to account for Northvale's review of the lands identified by the DCA for the land capacity factor with respect to the MOD-IV Property Tax List data, construction permit data, land use board approvals, configuration, and accessibility to ascertain whether these identified developable lands may accommodate development, and as further set forth in detail and explained in the attached memo prepared by Northvale's affordable housing planner, and Northvale seeks to commit to provide its fair share of 8 units present need and 99 units prospective need, subject to any vacant land and/or durational adjustments it may seek as part of the Housing Plan element and Fair Share Plan element it subsequently submits in accordance with the Amended FHA; and

**WHEREAS**, Northvale reserves the right to comply with any additional amendments to the FHA that the Legislature may enact; and

**WHEREAS**, Northvale also reserves the right to adjust its position in the event of any rulings in the *Montvale* case (MER-L-1778-24) or any other such action that alters the deadlines and/or requirements of the Amended FHA; and

**WHEREAS,** in the event that a third party challenges the calculations provided for in this Resolution, Northvale reserves the right to take such position as it deems appropriate in response thereto, including that its Round 4 Prospective Need Obligation should be lower than described herein; and

**WHEREAS**, in light of the above, the Governing Body finds that it is in the best interest of Northvale to commit to the modified present need and prospective need Fourth Round affordable housing fair share numbers set forth herein, subject to the reservations set forth herein; and

**WHEREAS**, in accordance with AOC Directive #14-24 dated December 13, 2024, the Governing Body finds that, as a municipality seeking a certification of compliance with the FHA, it is in the best interests of Northvale to direct the filing of an action in the form of a declaratory judgment complaint within 48 hours after adoption of the within resolution of fair share obligations, or by February 3, 2025, whichever is sooner.

**NOW, THEREFORE BE IT RESOLVED,** on this 15th day of January, 2025 by the Governing Body of the Borough of Northvale, County of Bergen, State of New Jersey as follows:

1. All of the above Whereas Clauses are incorporated into the operative clauses of this resolution.

Northvale hereby commits to [the DCA's Round 4 Present Need Obligation of 8 units] [no modification of the DCA's Round 4 Present Need Obligation of 8 units to 8 units], and [the DCA's Round 4 Prospective Need Obligation of 99 units] [a modification of the DCA's Round 4 Prospective Need Obligation of 112 units to 99 units], as explained above and in the attached memo from Northvale's affordable housing planner, and subject to all reservations of rights set forth above
- 3. Northvale hereby directs its attorney to file a declaratory judgment complaint in Bergen County within 48 hours after adoption of the within resolution and attaching this resolution as an exhibit with the attached memo.

Police had 683 total events for the month of December: 108 selective enforcement details, 98 motor vehicle stops, 37 school safety checks, 13 motor vehicle crashes, 37 burglary alarms, 34 suspicious incidents, 1 commercial burglary. Officers Sedano, Sullivan and Murphy received Shield awards from the Knights of Columbus for their resuscitative efforts performed on a female at the Rockleigh in December of 2023. Officers Albanese and Leenas received Valar awards from the Bergen County Police Chief's Association for their efforts in locating a subject response for a home invasion on July 27, 2024 in the Borough of Norwood. Officers Carroll, Criscuolo and Sullivan have all successfully completed the field training program and are now taking on full patrol duties within the work schedule.

**Councilman Bakalian** – there were no meetings in December for the Planning Board. The Building Department issued 20 permits and updated 1 permit. They are using a new software, SDL. The December report includes data from the last week of November. Fees collected for December 2024 were \$14,373 as compared to December 2023 of \$19,168. The year-to-date fees collected are \$238,667 which is \$46,350 more than last year.

**Councilman Menafra** – Fire Department stats for the month of December: 20 emergency calls totaling 106 man hours which include 13 fire alarms, 1 carbon monoxide alarm, 1 smoke condition and 1 non-structural fire. There were 17 non-emergency calls totaling 469 man hours including 3 company drills. Fire Prevention statistics for the month of December were 22 inspections and 19 re-inspections. Municipal Alliance has two events coming up – a parent focused Vaping 101 information session on Tuesday, January 28<sup>th</sup> from 6-7 pm in the Library and a student focused Rising Above the Vapor information session on Thursday, February 20th from 4-5 pm in the Library. Thank you to Lauren for arranging these events. Northvale Board of Education held their regular meeting on December 19<sup>th</sup>. Mr. Pinajian thanked Mrs. Cowley and Mrs. Marinuzzi for their work as board members. He also noted the success of a talk given by inspirational speaker Jordan Toma to 6<sup>th</sup> through 8<sup>th</sup> grade students during the week of December 8th. Jordan spoke about the academic and social emotional challenges he faced growing up as a student with a learning disability. The holiday concert was held on December 10<sup>th</sup>. The Board reorganization meeting was held on January 2<sup>nd</sup>. New board members Mrs. Horgan and Mrs. Sposa were sworn in. The next regular meeting is scheduled for January 23<sup>rd</sup> at 6:30 pm in the All Purpose Room. Northern Valley Regional High School last meeting was held on December 16<sup>th</sup>. The Superintendent reported that on December 9<sup>th</sup> the 2<sup>nd</sup> annual AI Summit will be held. Their reorganization meeting was held on January 6th. Newly elected and reelected board members Michael Caunedo, Beverly MacKeen, Michele LaTour, and GC Vaghasia were



sworn in. The two teams, Girls Volleyball and the football team, will be honored at the January meeting. The next regular meeting is scheduled for January 27<sup>th</sup> at 7:30 pm in the NVD Media Center.

Councilman Mattessich – did not get a chance to meet with Billy and Briant but will meet with them next week. The snowplows are ready and the streets were salted during the recent snow events. Normal maintenance continues with pothole repairs, brush pick up, appliance pickups, and installing street signs as necessary. The Senior Center will be closed on January 20<sup>th</sup> for Martin Luther King Day. The monthly breakfast will be held on January 21<sup>st</sup> at 10 am. On January 29<sup>th</sup> there will be a seminar for the seniors to discuss Medicaid with Robert J. Romano, Esq. The bathrooms were finished and came out great. The Golden Age Club Christmas party was held on December 11<sup>th</sup> at Aurora's in Old Tappan and Mayor McGuire, my wife Annette, and I had a great time celebrating with the members. New membership sign ups are this month. The club has so many members that they are only accepting applications from Northvale residents only. The last recreation meeting was held on November 19<sup>th</sup>. Congratulations to the winning teams that were honored tonight. Indoor soccer and basketball have started. The next meeting is January 21<sup>st</sup> at 7:30 pm.

**Councilwoman Fernandez** – the Library had a meeting on January 22<sup>nd</sup>. They will be having a movie matinee with Twister as the movie. It will be the Library's 10 year anniversary in 2025. We will be meeting to discuss the community garden.

**Councilman Sokoloski** – the Board of Health held their reorganization meeting on January 9<sup>th</sup>. All prior members are still holding office. The consultant working for Northern Valley Greenway has reached out to the Open Space Institute. They are talking with CSX about purchasing the abandoned rail line. This is the first time CSX is showing interest in this project. Requested grants pending total \$1,994,459 which has increased by \$150,000 since last month. We have reapplied for the new DPW garage grant for \$583,920 from the federal government. We are also applying for a CDBG grant of \$100,000 to pave the parking lot at Veterans Park and applying for a NJDOT grant to pave Pegasus Avenue. Grants awarded so far total \$1,595,802.

Mayor McGuire – At yesterday's State of the State address by Governor Murphy he outlined his plans for this year. One item that causes great concern for everyone in our area is his commitment to essentially gut local zoning laws and pave the way for "thousands and thousands" of apartments/affordable housing. I cannot disagree more with the Governor on this initiative and it is a threat to everyone who wishes to live in suburbia. It's not right and I stand with my fellow Mayors in this area, Democrat and Republican, along with this Council stating that we will fight this initiative with everything we have.

**Mr. Ralph** – since the resolution was just passed authorizing the Borough Attorney to file a declaratory judgment complaint, the complaint will be filed tomorrow.

## **BOROUGH ENGINEER REPORT**

**Mr. Loverich** – the contractor will be here tomorrow to install the benches and trash cans on Livingston Street which should be a one day project. Next week, the contractor will fix the basin on Andre Avenue.

### Mayor McGuire opened the meeting to the public.

Chris Bombino, 123 Rockland Avenue – asked if the headcount was done at Cho Dae Church. Mayor McGuire informed him that our Construction Code Official went to the church and advised that they are not over capacity. Mr. Bombino went over the emails that he sent to the Chief and Mayor and Council with violations from December 15<sup>th</sup>, December 22<sup>nd</sup>, and this past Sunday. He requested permanent signage from the corner to the fire hydrant and would like to have the cones removed Sunday nights. There have been vehicles waiting to pick up people which he feels is due to this new ordinance. He has seen cars enter Mufson and not come out. If this ordinance will not be changed, he will share the evidence at every meeting with the Mayor and Council. He spoke with a guard at the church who has spoken with the Elders and does not like the new configuration. He would like to take videos to show the Council.
