CALL THE MEETING TO ORDER

Mayor Marana called the meeting to order at 7:00 PM in the Council Chambers at 116 Paris Avenue, Northvale, New Jersey 07647.

STATEMENT

RESOLUTION #2022-181

TITLE: RESOLUTION AUTHORIZING TEMPORARY APPOINTMENT OF CHRISTOPHER MARTONE AS TEMPORARY JUDGE FOR THE NORTHVALE MUNICIPAL COURT

- **WHEREAS,** pursuant to N.J.S.A. 2B:12-5, a temporary judge may be appointed to meet a special need of limited duration; and
- **WHEREAS,** with the written consent of the Assignment Judge of the vicinage, a municipality may appoint one or more temporary municipal judges; and
- **WHEREAS,** Northvale previously appointed Robert Hauser to serve as the Municipal Judge for the Borough of Northvale; and
- **WHEREAS,** Judge Hauser has, at times, been unable to serve due to temporary personal reason necessitating the appointment of a temporary municipal Judge in his sted; and
- **WHEREAS**, request was made to the Bergen County Assignment Judge, Judge Misdol, requesting authorization to appoint a Temporary Judge for the Borough of Northvale; and
- **WHEREAS,** by notice dated December 2, 2022 attached to this Resolution, the Borough has received authorization to appoint by resolution one temporary Judge for the Northvale Municipal Court for a period not to exceed one (1) year; and
- **WHEREAS,** Christopher Martone is a member of the New Jersey Bar in good standing and has applied to serve as the Temporary Judge of the Municipal Court of the Borough of Northvale; and
- **WHEREAS,** it is in the best interest of the Borough to appoint Christopher Martone as the Temporary Municipal Judge of the Borough of Northvale.
- **NOW, THEREFORE BE IT RESOLVED,** that Christopher Martone is hereby appointed as the Temporary Municipal Judge effective immediately, at a rate of \$250.00 per Court Session for a term not to exceed one (1) year.

RESOLUTION #2022-182

TITLE: RESOLUTION AUTHORIZING EXECUTION OF CONTRACT WITH CAPTAIN CHRISTOPHER MAZZILLI

WHEREAS, Christopher Mazzilli was promoted to the position Captain of the Northvale Police Department on September 28, 2022; and

WHEREAS, it is the best interest of the Borough to provide a contract of employment to Christopher Mazzilli detailing the Borough's and Captain Mazzilli's expectations and benefits of employment (the "Contract"); and

WHEREAS, the Borough Attorney has prepared and reviewed the Contract, annexed to this Resolution, and recommends the Governing Body authorize the execution of the Contract.

NOW, THEREFORE BE IT RESOLVED, that the Mayor is hereby authorized to execute the Contract attached to this Resolution said Contract being effective as of the date of Captain Mazzilli's promotion of September 28, 2022.

RESOLUTION #2022-183

TITLE: CANCELLING APPROPRIATIONS IN THE CURRENT FUND OPERATING BUDGET FOR 2022 TOTALING \$115,000

WHEREAS, unexpended balances exist in the 2022 Operating Budget for Current Fund; and

WHEREAS, it is necessary to officially cancel such balances so funds can be transferred to Surplus at year-end, and anticipated as Revenue item in the following year budget; and
